The *Expression of Interest* is the first step enabling us to organise as accurately as possible the DC 1's deliveries and the allocation of the first series' numbered models.

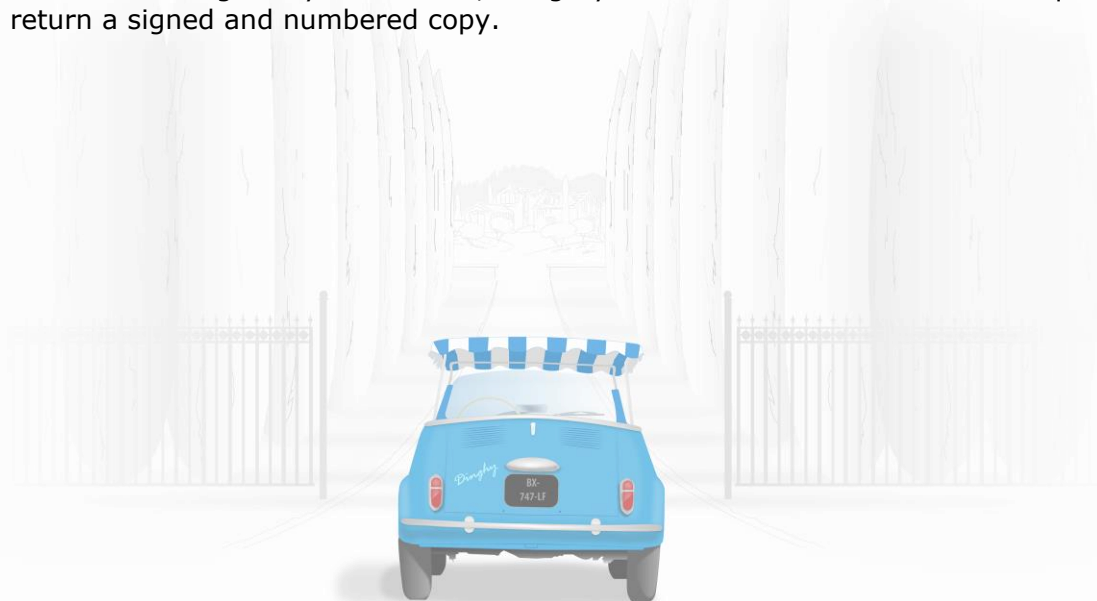

THE DC 1

Dinghy offers iconic vehicles with electric motors, powerful and adapted to the constraints of modern-day traffic patterns whilst maintaining the aesthetics, the usage philosophy and the sheer pleasure of the original vehicle.

Dinghy's first production, code-named DC 1, will be inspired by the Fiat 500 Jolly Ghia, the icon of the 60's "jet set" during their stays on the Riviera. This open-topped version, equipped with rattan seats, designed to move at restrained speeds over short distances, reveals its full potential thanks to electric propulsion: original performances are retained, flexibility and silence are gained!

The DC 1 will be certified for 4 passengers.

The first 99 copies will make up a limited and numbered series.

FROM EXPRESSION OF INTEREST TO THE RECEIPT OF YOUR DC 1

In order to organise as accurately as possible the DC 1's deliveries and the allocation of the first series' numbered models, five steps leading up to your vehicle's delivery have been defined:

- 1. The expression of interest:** the first of these steps, the expression of interest, is free and non-binding. It allows you to register as early as possible into the DC 1's production schedule and for the allocation of the numbered models. It shall be available until the implementation of pre-ordering and guarantees its signatory first-come-first-served priority for such pre-ordering. The first 99 expressions of interest that result in a firm order will be granted, in addition to a numbered vehicle from the initial series, a 5% discount on the final sales price.
- 2. Pre-orders:** scheduled for the second quarter of 2017, the pre-ordering phase will require a deposit of 10% of the targeted sales price. Pre-order numbers will facilitate the gathering of firm orders, the allocation of the 99 numbered vehicles from the initial series, and the actual production.
- 3. Firm orders:** these will be available following the presentation of the certified vehicle. Firm orders shall be registered in keeping with pre-order numbering. They shall be accompanied by the payment of a deposit for 30% of the confirmed sales price.
- 4. Production launch:** before production begins on your vehicle we will contact you to confirm your chosen options (colour, etc.) as well as the delivery schedule. The balance of the vehicle's sales price will be required before production can begin. Gentlemen Drivers' aims to deliver its first vehicles during the summer of 2018.
- 5. Hand-over** of your DC 1
